For those applicants not meeting all the requirements, yet the cover letter information supports acceptance, they may be accepted with a two-thirds majority (66.67%) vote by the board.*

1. Bowler must be at least 40 years of age (date of birth required on page 1).
2. Bowler must have been a member of this **Local Association** for at least 20 years.
3. Bowler must have demonstrated service, devotion and an unselfish contribution of their time above and beyond the ordinary to the sport of bowling. (Examples should be included in your cover letter.)
4. Bowler must have represented themselves in a positive manner befitting the Eastern Shore USBC Hall of Fame. For example, not speaking or acting in a negative way about our association or its Hall of Fame.

**ADDITIONAL REQUIREMENTS** – Must meet at least one (1) of the following or two (2) of the following for half of the time specified. The nominee must have

1. Been a **Local Association** board member for 10 or more non-consecutive years.

3. Bowler must have demonstrated service, devotion and an unselfish contribution of their time above and beyond the ordinary to the sport of bowling. (Examples should be included in your cover letter.)
4. Men: 200+ average for at least ten (10) non-consecutive years or 215+ average for at least five (5) non-consecutive years.  
Women: 180+ average for at least ten (10) non-consecutive years or 190+ average for at least five (5) non-consecutive years.
